JAMES Q. SWIFT, DDS, is a Professor in the Division of Oral and Maxillofacial Surgery at the University of Minnesota School of Dentistry. He is a graduate of Cornell College, Mt. Vernon, IA, the University of Iowa College of Dentistry and completed a General Practice Residency at Oklahoma Children's Memorial Hospital. He completed his oral and maxillofacial surgery residency training program at the University of Oklahoma Health Sciences Center.

He began his academic career as an assistant professor at the University of Oklahoma Health Sciences Center, in the College of Dentistry. He had teaching responsibilities with the dental students and the oral and maxillofacial surgery residents. He served on two cleft palate/craniofacial teams.

CHARLES W. WAKEFIELD, DDS, MAGD, ABGD, FICD, FACD, attended UCLA School of Dentistry and completed a two year AEGD Residency during his 21 year US Army career. He is Board Certified by the Federal Services and American Boards of General Dentistry and is a Fellow of the American and International Colleges of Dentistry. He has been the Director of AEGD programs at Fort Benning, Georgia, Fort Hood, Texas and Medical University of South Carolina. He holds the Surgeon General's "A" designator and is an Adjunct Professor of Comprehensive Dentistry at the Uniformed Services University of the Health Sciences and was a tenured Professor and Director of the AEGD Residency Program at Baylor College of Dentistry, Dallas, Texas from 1995-2015. Currently, he is in private practice in Lewisville, Texas with his son, Brian Wakefield, DDS, FAGD.
